

## **Madrid Protocol Concerning the International Registration of Marks**

### **Digital Attestations, Copies of Entries in and Extracts from the International Register**

1. In accordance with Article 5<sup>ter</sup> of the Protocol Relating to the Madrid Agreement Concerning the International Registration of Marks and upon the payment of the fees specified in Item 8 of the Schedule of Fees, the International Bureau of the World Intellectual Property Organization (WIPO) shall issue attestations, copies of entries in and extracts from the International Register.
2. The International Bureau of WIPO is pleased to announce that, effective immediately, it will issue digital versions of the above-mentioned documents in portable document format (PDF) and with an electronic signature. In addition, the documents will have a new design (see Annex). The International Bureau of WIPO will transmit these digital documents by electronic mail.
3. Users of the Madrid System who wish to receive a paper version of the above-mentioned documents by post, in addition to the digital version, must indicate so when presenting their requests. Users who request legalized documents will continue to receive paper versions of these documents by post.
